Under arbetet med den här boken hämtade jag underlag från handskrivet material, arkiv och bibliotek i England, Amerika, Tyskland och Australien. På Kungliga Arkivet i Windsor Castle i England har jag läst brev mellan Victoria och hennes man, barn, premiärministrar, ministrar, präster, vänner och hovfolk.

Victoria lämnade enorma mängder text efter sig, och numera finns hennes dagböcker tillgängliga på internet, vilket är till glädje för forskare. Det är hundra år sedan Arthur Christopher Benson, lord Esher och senare George Earle Buckle, åtog sig den kolossala uppgiften att redigera hennes brev. Victorias brev till den äldsta dottern förvaras på Friedrichshof i närheten av Frankfurt i Tyskland, och förvaltas av Kurhessische Hausstiftung, familjestiftelsen för Hessiska ätten. Roger Fulford redigerade dem mellan 1964 och 1981, och Agatha Ramm publicerade slutligen den sista volymen 1991.
